****Theatre Custodian – Part Time**

Requirements:

****Bartender (Theatres @ MOA) – Full Time & Part Time**

Requirements:

Must be at least 21 years of age or older

One to two years experience bartending or completion of a certified bartending school required

Extensive knowledge of alcoholic menu

Outstanding interpersonal and communication skills

Strong multi-tasking abilities

Knowledge of alcohol laws and provisions

Previous cash handling experience

Responsibilities:

Working in the VIP area of Theatres @ Mall of America

Greet guests in a friendly, professional manner

Prepare and serve alcohol and non-alcoholic beverages

Handle monetary transactions using a point of sale system
Ensure that all monetary transactions are completed using established cash handling procedures
Maintain station cleanliness and stock levels

Requirements:

Previous experience using cleaning machines such as floor buffers and scrubbers.
Working knowledge of the safe handling of equipment and materials uses in custodial duties
Ability to perform some or all of the physical tasks involved in lifting, scrubbing, sweeping, mopping and other custodial duties
Ability to work variable and/or rotating shifts including nights, weekends and holidays
Ability to understand simple verbal and/or written instructions

Responsibilities:

Provide outstanding internal and external guest service at all times
Checks and removes all trash
High dusts all vents, wipes down all walls, vending machines and baby changing stations
Cleaning restrooms throughout the Mall
Performs personal inspection to determine if restroom is ready for use
Check equipment prior to use, performs simple preventative maintenance according to schedule
May be asked to operate power equipment associated with custodial duties
Due to the team focused environment of the company, employees may be asked to provide support in other work areas as needed, performing other duties that may be assigned

****Waste & Recycling – Full time**

Requirements:

Must be at least 18 years of age or older
Ability to work variable and/or rotating shifts, including nights, weekends and holidays
Must be able to safely perform the physical tasks involved with lifting, sweeping, mopping, driving and operating power custodial equipment

Responsibilities:

Empty trash containers into compactors and operate compactors
Lift trash bags into waste containers
Move wheeled trash barrels from recycling rooms throughout the Mall to loading dock areas
Sweep and operate power scrubber to clean service corridor floors
Empty grease barrels in restaurants and food court tenants
Ensure the overall safety of the immediate work area as well as surrounding areas
Provide outstanding internal and external guest service at all times
May operate Cushman cart with trailer to haul waster containers
Due to the team focused environment of the company, employees may be asked to provide support in other work areas as needed, performing other duties that may be assigned

SECURITY

****Security Officer – Full time**

Requirements:

High school diploma or equivalent
Three months prior experience in a security/criminal justice related position

Working knowledge of state and federal criminal justice statutes and law enforcement procedures preferred
Must be able to meet the physical demands of the position including: frequent and sustained walking, occasional running, bending, stooping, squatting, twisting, crawling and frequent and extensive use of hands and arms
Must be eligible to be licensed as a Security Officer in the State of Minnesota this requires that you have no record of conviction for crimes against persons or property as revealed through a fingerprint check with the Minnesota Bureau of Criminal Apprehension and/or the FBI
Must possess outstanding guest service skills

Responsibilities:

Patrol MOA property including mall common areas, service corridors and parking lots to provide protection for life and property
Perform various guest relations activities including but not limited to providing directions to guests, assisting in the location of lost persons, cars, etc.
Conduct periodic safety/fire inspections as assigned
Complete and accurate reports as required, including incident, accident or personal injury reports
Keep dispatcher and supervisors informed of all pertinent incidents and activities according to department guidelines
Ensure the overall safety of the immediate work area as well as surrounding areas
Due to the team focused environment of the company, employees may be asked to provide support in other work areas as needed, performing other duties that may be assigned including but not limited to typing, filing and other clerical or security related duties

****P.E.P. Security Officer – Part time**

Requirements:

Would be working primarily Friday and Saturday evenings, enforcing Mall of America parental escort policy

High school diploma or equivalent required, post secondary education preferred
Must have good customer relations skills and have the ability to remain calm and effective in stressful situations
No record of conviction for crimes against persons or property, must possess a valid driver's license and must submit to drug and alcohol testing as a condition of employment

Ability to communicate effectively over the radio required

Requirements:

Lighting experience is preferred

Responsibilities:

Set up and run audio cables for live shows and events
Provide AV support for clients renting the ballroom
Set up and running of audio and lighting effects for special events through the park, mall and theatres
Perform minor repair and maintenance of equipment
